





Enhanced Support Payments to Chapters & State Councils

SHRM Chapters and State Councils in good standing will be eligible for enhanced financial support based on the number of SHRM members who <u>recertify</u> between January 1, 2017 and December 31, 2017.

- Chapters in good standing will receive \$20 per each chapter member who is a SHRM member in good standing, primarily coded to the chapter, and <u>recertifies</u> for SHRM Certification during 2017
- State Councils will receive \$10 per each SHRM member in good standing (in-chapter and at-large) in the state who <u>recertifies</u> for SHRM Certification during 2017
- Payment will be made to affiliates in good standing in early 2018 based on the number of <u>recertified</u> members meeting the above criteria as of December 31, 2017




